Pennsylvania ARP Nominations for Non-Affiliated Governing Committee Representatives – Non-Affiliated Subscribers to the Pennsylvania Assigned Risk Plan

The Pennsylvania Assigned Risk Plan, Section 49, requires the Manager to poll the non-affiliated member companies prior to the biennial meeting to determine those companies desiring to serve on the Governing Committee. Subsequently, a mail vote of the non-affiliated companies is conducted to elect the Governing Committee representatives. The two non-affiliated companies presently serving on the Governing Committee are:

- Nationwide Mutual Insurance Company
- State Farm Mutual Auto Insurance Company

Those non-affiliated companies offering to serve on the Plan's Governing Committee for the 2020-2022 term are asked to complete the attached form and return it to the Plan office by May 4, 2020. All non-affiliated companies offering to serve will be placed on a ballot from which all non-affiliated subscribers to the Pennsylvania Plan will elect one company to represent them. The two companies garnering the highest number of votes will serve on the Governing Committee based upon procedures outlined in the Plan.

The 2020 Pennsylvania Assigned Risk Plan Biennial Meeting is scheduled December 2, 2020 at 9:00 a.m. at the office of the New Jersey Automobile Insurance Plan, 10000 Midlantic Drive, Mount Laurel, New Jersey. The results of the non-affiliated companies' vote will be announced at this meeting. Once elected, Governing Committee representatives will be required to attend meetings and be available to serve on Plan subcommittees, if necessary.

Further, any company that receives this circular and is currently affiliated with a trade association is not eligible to place its name in nomination or cast a ballot for non-affiliated company representatives. For those companies, we ask that the ballot be returned noting the trade association with which your company is presently affiliated in order that Plan staff may update its records.
