**NEW JERSEY PERSONAL AUTOMOBILE INSURANCE PLAN
CO-LESSEE/GUARANTOR CERTIFICATION FORM**

Instructions for Completion: Leased vehicles are eligible for coverage through the New Jersey Personal Automobile Insurance Plan provided the requirements in Article 3 of the Plan of Operation are met. If a co-lessee/guarantor is named on the lease, acting as a financial guarantor, and does not reside in the same household as the applicant/lessee, this form must be completed and notarized. The co-lessee/guarantor must provide evidence of current in force auto liability insurance with at least the same liability and uninsured/underinsured motorist limits as the leased vehicle. The producer will furnish the applicant/lessee and co-lessee/guarantor with copies of the completed form.

Submission of Form with Plan Application: A completed notarized Co-Lessee/Guarantor Certification Form and evidence of current auto liability insurance must accompany the application for assignment. A copy of the lease agreement must also accompany the application.

In Force Policies: When a policy change request is submitted to the insurer at any time during the policy period for an additional or replacement leased vehicle, a completed notarized Co-Lessee/Guarantor Certification Form must be attached. The co-lessee/guarantor must also provide evidence of current auto liability insurance. A copy of the lease agreement must also accompany the policy change request.
